Land Package Price per person sharing a double room

\$3,240	Based on a minimum of 15 paying participants
\$3,550	Based on a minimum of 12 paying participants
\$3,740	Based on a minimum of 10 paying participants

If there will be less than 10 paying participants the price per person will increase.

For single hotel room accommodations please add \$800 (limited availability)

Please note that all listed prices are valid for tourists only (non-Israeli citizens). Israeli citizens will need to add 17% Value Added Tax to a portion of the trip cost as per Israeli law.

Accommodations will be at Ohalo Manor overlooking the Sea of Galilee March 2 - 4 and the Prima Royale Hotel in Jerusalem March 4 - 10

The land package price includes:

8 nights hotel accommodations, 8 hotel breakfasts, 8 dinners, 3 lunches, volunteer activities and solidarity visits, visits to communities in Judea and Samaria, historic/Biblical site visits, tips for drivers, guides and waiters at included meals and private group bus transportation in Israel

Not included in the land package price:

Airfare, meals on your own, personal charges at hotels and restaurants, private airport transfers, medical and travel insurance

The trip is being offered on a "land only" basis with each participant making their own flight arrangements. Keshet assumes no responsibility for flight arrangements, delays or cancellations. There will be one group bus pick up from Ben Gurion Airport on Sunday March 2 timed to the arrival of most of the group. There will be one group bus drop off at Ben Gurion Airport at the conclusion of the trip on Monday March 10 timed to the departure of most of the group. Should your flights arrive or depart at times/dates different from the group you will be responsible for the cost of your own airport transportation. The Keshet staff will be happy to assist trip participants with any additional transportation, accommodations or touring services that might be needed prior to or after the trip

Registration & Payment Schedule

<u>Step 1 – Registration</u> The initial registration is **without payment** and is an indication of your intention to participate in the trip so that we know how many people are interested. Please complete the on-line registration form by **November 1, 2024.** Here is the registration link:

Step 2 - Payment of \$500 per person due by November 20, 2024

Keshet will send invoices with payment instructions for payment online with Visa or Mastercard.

Step 2 – Final Trip Payment per person due by January 16, 2025

Keshet will send invoices with payment instructions for payment online with Visa or Mastercard.

Cancelation & Refund Schedule

If Keshet needs to cancel the trip after February 18 due to Israeli security regulations or other reasons beyond Keshet's control, all funds paid to Keshet/EEII will be refunded less \$550 per person.

If trip participant(s) cancel their participation in the trip, the following refund schedule below apply:

For cancellation or non-participation for any reason including health reasons, flights and security related concerns.

Cancellation Period	Refund
From November 20	Full refund less \$150 per person
From January 16	Full refund less \$1,000 per person
From February 6	Full refund less \$2,500 per person
From February 24	Full refund less \$3,000 per person

If the trip organizers and/or trip participants decide to cancel or postpone the trip, the refund schedule above will apply

Keshet strives to offer fair pricing and therefore does not budget for contingencies resulting from weather or security issues. Itineraries may be altered as a result of these factors. Also, the prices listed are based on regular tourism regulations and reflect rates quoted by hotels and vendors as of September 2024. In the event of changes in regulations that influence the price of the tour and/or devaluation of the US dollar exchange rates, hotels and other vendors may add surcharges; Keshet reserves the right to pass such increases on to trip participants. Please note that if the trip organizers decide to cancel or postpone the group trip or if the trip is canceled due to circumstances beyond the control of Keshet, the refund schedule above will apply.

Keshet strongly urges you to purchase trip cancellation/interruption insurance and supplemental medical coverage (which covers pre-existing conditions). We recommend the "Cancel For Any Reason" policies which offer the broadest coverage, including partial coverage for trip interruption or cancellation or withdrawal on your part due to health issues, pandemic and security related reasons. Most insurance policies require purchase within 10 days of your date of first payment for the trip. Please note that we cannot accept responsibility for any losses or expenses which you or any member of your party may incur as a result of failure to secure adequate insurance coverage.
